### **SECTION 709-CONTROL OF UNITS**

**POST OFFICERS**: Please review Section 709, Control of Units, in the National By-Laws and Manual of Procedure in its entirety. You are not authorized to sell or transfer property, borrow against the assets of the VFW Post without the full knowledge and consent of the Post membership thirty (30) days prior to the sale, purchase, transfer or encumbrance. You must advise all members of the meeting where there will be a discussion of such action. You must notify Department Headquarters of the outcome of this meeting at which time the State Commander will either approve or disapprove the action. Only then will they authorize the Post to continue with the sale, purchase, transfer or encumbrance. You are reminded that you have a fiduciary responsibility in the position you have been elected to. Any deviations from said By-Laws will nullify the transaction and any officers violating these By-Laws will be subject to removal.

### <u>INTERNAL REVENUE SERVICE FORM 990</u>

The deadline for filing the Federal IRS Form 990 is November 15<sup>th</sup> and the IRS can levy a \$10.00 per day penalty for every day the 990 Form is late. The forms are available on the IRS's website at <a href="www.irs.gov">www.irs.gov</a>. It is the responsibility of the Post Commander and Quartermaster to make sure this form is prepared and submitted on time to the IRS. *Please forward a copy of your completed 990 to this Headquarters*.

### **AG-990 STATE OF ILLINOIS**

Any Post that has applied for a Bingo License, Las Vegas Night License and Gaming License or a Pull Tab License will probably be receiving an AG-990 Form from the State of Illinois Attorney General's office for filing and if you have one of the above licenses, you are required to file this form unless your Post as received an exemption from the Attorney General's Office. *Please forward a copy of your completed AG990 to this Headquarters*.

### IRS FORM 990-T

VFW Posts that have unrelated business income must file an IRS Form 990-T. The 990-T must be filed by November 15<sup>th</sup> of each year and this form is available on the IRS's website at <a href="www.irs.gov">www.irs.gov</a>. It is the responsibility of the Post Commander and Quartermaster to make sure this form is prepared and submitted on time to the IRS. *Please forward a copy of your completed 990-T to this Headquarters*.

### **POST RELIEF FUND**

Section 704 of the Manual of Procedure outlines the various things for which the Post Relief Fund can be used.

(a) Aid, assistance, relief, and comfort of needy or disabled veterans or members of the Armed Forces and their dependents, and the surviving spouses and orphans of deceased veterans.

- (b) Maintenance and expansion of the VFW National Home for Children and other facilities devoted exclusively to the benefit and welfare of the dependents, surviving spouses, and orphans of disabled, needy or deceased veterans or members of the Armed Forces.
- (c) Necessary expenses in providing entertainment, care, and assistance to hospitalized veterans or members of the Armed Forces.
- (d) Veterans rehabilitation, welfare and service work.
- (e) To perpetuate the memory of deceased veterans and members of the Armed Forces, and to comfort their survivors.
- (f) To foster true patriotism through historical and educational programs.

Relief funds may be invested in approved securities but shall not be loaned to the Post or other units, or transferred from the relief fund in any manner or under any guise, except that relief funds may be transferred to the general fund for remission of dues of sick, needy or disabled members

### The Trustee Report of Audit MUST show a Relief Fund!

### V.F.W. POST INSURANCE INFORMATION

All VFW Members in good standing receive up to \$1,000 of Accidental Death and Dismemberment Insurance protection, underwritten by Securian Life Insurance Company, at no-cost to the member. If a covered members' death results from an accident while travelling as a fare-paying passenger in a commercial vehicle, an additional VFW Travel Accident Benefit of \$1,500 will be payable, for a maximum total of up to \$2,500.

All benefits reduce to 50% at age 75 regardless of age at enrollment. Claims for accidents after August 1, 2018 should be reported to (877) 850-0183.

### FIDUCIARY RESPONSIBILITIES OF THE COMMANDER

Your attention is drawn to Section 218 of the National By-Laws.

Among the duties of a Post Commander, the Commander shall:

- g. Assure that the office of the Quartermaster is bonded according to Section 703 of the By-Laws
- h. Assure that all dues and other monies due the National Headquarters and Department are forwarded promptly together with accurate reports and returns pertaining thereto.
- i. Assure that all reports are correctly prepared and promptly forwarded, that all the business of the Post is handled with dispatch and that all necessary licenses and permits are obtained for proper operation. Ensure that a properly completed Report of Election of Officers for the ensuing year is submitted to Department and National Headquarters by June 1.
- j. Assure that the Post Trustees have examined the books and records of the Post and prepared the Post Trustees Quarterly Report of Audit no later than the end of the month following the last day of each quarterly period.

### **RESPONSIBILITY OF TRUSTEES**

Each VFW Post shall have <u>three elected trustees</u> who will, at least monthly, review the Monthly Report of Receipts and Expenditures of the Post Quartermaster. Within thirty (30) days from the end of each quarter, they should properly audit the books and records of the Post Quartermaster and submit a Post Trustee's report of Audit to the Department Quartermaster for referral to the Department Inspector. Please see Sec. 218 of the National By-Laws and Manual of Procedure for complete information on the duties of Post Officers.

### **PLEASE NOTE:**

Before the Department Headquarters accepts an audit, it must be signed by the trustees. You may mail or fax the form to HQ, or you may scan the signed form and email it to HQ, at vfwil@vfwil.org.

### COMMUNITY SERVICE GUIDELINES FOR REPORTING

When you are reporting on your activities, please remember - The money that should be reported are the dollars donated or expended in the performance of the community service hours reported, plus \$0.14 per mile for each mile driven by the volunteers. Posts should not report any figure derived from the value of hours worked.

### **POST COMMANDER & QUARTERMASTER AWARD**

Posts recruiting 5% of their prior membership (as recorded on Memstats as new and reinstated members), with a minimum of six members, by January 15, 2022 will receive a special award. The Post Commander and Quartermaster will receive a special embroidered State Commander's jacket. (Note: Partial numbers will be rounded up to the next whole number). Jacket size forms will be sent to qualifying Post Commanders and Quartermasters and these forms must be <u>received</u> at State Headquarters no later than February 15, 2022.

### **SITUATION:**

Asthma is a long-term disease of the lungs. It causes your airways to get inflamed and narrow, and it makes it hard to breathe.

Asthma is a serious disease that affects about 25 million Americans and causes nearly 1.6 million emergency room visits every year.

MISSION: To educate and minimize the risk factors associated with Asthma.

### **EXECUTION:**

Asthma is marked by inflammation of the bronchial tubes, with extra sticky secretions inside the tubes. People with asthma have symptoms when the airways tighten, inflame, or fill with mucus.

There are three major signs of asthma: (1) Airway blockage. When you breathe as usual, the bands of muscle around your airways are relaxed, and air moves freely. But when you have asthma, the muscles tighten. It's harder for air to pass through. (2) Inflammation. Asthma causes red, swollen bronchial tubes in your lungs. This inflammation can damage your lungs. Treating this is key to managing asthma in the long run. (3) Airway irritability. People with asthma have sensitive airways that tend to overreact and narrow when they encounter even slight triggers. Symptoms presents as: Coughing, especially at night or in the morning; wheezing,

a whistling sound when you breathe; Shortness of breath; tightness, pain, or pressure in your chest; trouble sleeping because of breathing problems. Not every person with asthma has the same symptoms in the same way. You may not have all these symptoms, or you may have different symptoms at different times. Your

symptoms may also vary from one asthma attack to the next, being mild during one and severe during another. Some people with asthma may go for long periods without having any symptoms. Others might have problems every day. In addition, some people may have asthma only during exercise or with viral infections like colds. Mild asthma attacks are generally more common. Usually, the airways open within a few minutes to a few hours. Severe attacks are less common but last longer and require medical help right away. It is important to recognize and treat even mild asthma symptoms to help you prevent severe episodes and keep asthma under better control.

### **SERVICE AND SUPPORT:**

Medication will probably be key to getting your asthma under control, but you can do some things at home to help like avoid asthma triggers; exercise regularly; stay at a healthy weight; take care of conditions that can trigger symptoms, such as GERD; do breathing exercises to ease symptoms so you need less medication; some people use complementary treatments such as yoga, acupuncture, biofeedback, or supplements like vitamin C and ding chuan tang. Talk to your doctor before trying any of these. Also,

talk to your doctor about vaccines to lower your chances of certain conditions. You might get vaccinations for COVID-19, flu, pneumonia, shingles, or whooping cough (pertussis).

Types of Asthma medications

Category Purpose Types Long-term asthma control medications Taken regularly to control chronic symptoms and prevent asthma attacks — the most important type of treatment for most people with asthma \*Inhaled corticosteroids \*Leukotriene modifiers \*Long-acting beta agonists (LABAs) \*Theophylline \*Combination inhalers that contain both a corticosteroid and a LABA (see examples below) Quick-relief medications (rescue medications) Taken as needed for rapid, short-term relief of symptoms — used to prevent or treat an asthma attack \*Short-acting beta agonists such as albuterol \*Ipratropium (Atrovent) \*Oral and intravenous corticosteroids (for serious asthma attacks) (see examples below) Medications for allergy-induced asthma Taken regularly or as needed to reduce your body's sensitivity to a particular allergy-causing substance (allergen) \*Allergy shots (immunotherapy) \*Allergy medications Biologics Taken with control medications to stop underlying biological responses causing inflammation in the lungs — used to better manage severe asthma symptoms \*Omalizumab (Xolair) \*Mepolizumab (Nucala) \*Benralizumab (Fasenra) \*Reslizumab (Cinqair)

Examples of inhaled corticosteroids include Fluticasone (Flovent HFA); Budesonide (Pulmicort Flexhaler); Mometasone (Asmanex Twisthaler); Beclomethasone (Qvar RediHaler) and Ciclesonide (Alvesco) Examples of Leukotriene modifiers include Montelukast (Singulair); Zafirlukast (Accolate); and Zileuton (Zyflo)

Examples of Long-acting beta agonists (LABAs) is salmeterol (Serevent)

Examples of combination inhalers which is a corticosteroids and long-acting beta agonists include Fluticasone and salmeterol (Advair Diskus); Budesonide and formoterol (Symbicort); Mometasone and formoterol (Dulera); and Fluticasone and vilanterol (Breo)

Examples of quick-relief medications include Albuterol (ProAir HFA, Ventolin HFA, others) and Levalbuterol (Xopenex HFA)

Examples of oral corticosteroids for serious asthma attacks include Prednisone and Methylprednisolone

### VA expands offering of COVID-19 booster vaccines

**WASHINGTON** — The Department of Veterans Affairs is now offering Moderna and Johnson & Johnson (J&J)/Janssen COVID-19 vaccine booster shots under Emergency Use Authorization, expanding on last month's authorization of the Pfizer-BioNTech booster.

This decision follows this week's Food and Drug Administration's authorization and Centers for Disease Control and Prevention's recommendation for a booster dose using the Moderna or J&J vaccines.

"Booster shots are an important step forward in the fight against COVID-19," said VA Secretary Denis McDonough. "With the authorization of additional COVID-19 vaccine booster options, VA is helping more Veterans maximize their protection, continuing our work to keep people safe and save lives during the COVID-19 pandemic."

VA will follow CDC guidance in offering COVID-19 booster shots:

For individuals who completed a Pfizer-BioNTech or Moderna COVID-19 vaccine series, the following groups are eligible for a booster shot at least 6 months after their second dose:

65 years and older.

Age 18+ who live in long-term care settings.

Age 18+ who have <u>underlying</u>

medical conditions. Age 18+ who

work or live in high-risk settings.

People 18 years and older are eligible to receive a COVID-19 booster shot at least 2 months after their initial J&J vaccine.

Eligible individuals may choose which vaccine they receive as a booster dose. Some people may have a preference for the vaccine type that they originally received and others, may prefer to get a different booster. CDC's recommendations now allow for this type of mix and match dosing for booster shots.

The safety and care of Veterans is VA's top priority, as well as ensuring the health and welfare of its workforce. Many sites in VA are open for walk-ins during hours when vaccine clinics are operational, and where booster vaccines are available. Booster shots are being offered to Veterans receiving care at VA and employees. VA is also offering the booster to Veterans, their spouses, caregivers and CHAMPVA recipients under the authority of the <u>SAVE LIVES Act</u>, as supply and capacity permits. The Save Lives Act which was signed into law in March 2021 expanded <u>VA's authority to offer vaccine</u> to include Veterans not traditionally eligible for VHA care, and others including spouses and caregivers of Veterans.

CDC advises that people can get both the COVID-19 vaccine and flu vaccine at the same time. Veterans receiving care at VA who wish to get a booster shot can get both shots together during the same visit.
